Kerry will move forward in creating a cover for the compressor before fixing the compressor and then proceed with the compressor fixes. Exhaust fans are currently venting into the attic and are not compliant to building codes. Kerry will move forward to getting ventilation corrected to code. Dump station sensory battery needs to be replaced. Jim will look into the issue. Next date for dump station pump out will be set at the March meeting.
