ARE YOU INTERESTED IN SERVING ON THE LV RANCH BOARD?

Especially for the benefit of our newer members, please be aware that opportunities to serve on the LV Ranch Board of Directors become available at each Annual Meeting in August, and sometimes sooner. The LV Ranch Board manages the expenditures of the membership's annual dues and is responsible for maintaining all aspects of the LV Ranch facility, including: upkeep of the Ranch House; the roads; the lakes and restocking the fish; road and lot signage; lot rule compliance issues; processing new membership applications; and, all of the administrative and record keeping functions required to maintain a not-for-profit corporation. Serving on the Ranch Board doesn't mean that each individual Board member has to do all the work in an assigned area. Rather, it often involves coming up with a strategy for accomplishing individual tasks and often contracting with businesses who perform the type of work needed. For example, actual tax accountants prepare the corporate tax filings, general or specialized contractors typically perform the needed plumbing and electrical repairs to the Ranch House, an experienced road grader operator is typically retained to perform the major road repairs, etc. Accordingly, the Ranch Board functions best when its Board members have a wide-range of varying understandings and experiences. No particular job skill is needed to serve as an LV Ranch Board Member

The Ranch Board holds scheduled Board Meetings every-other-month. Since COVID, all Board Meetings (except for the June and August meetings) have been remotely convened via ZOOM. That's been so convenient for everyone, that there's been no reason to switch back to regular, in-person Board Meetings. The LV Ranch Board is composed of nine volunteer members who each serve a three-year term. Those three-year terms are staggered so that three board member terms expire at each Annual Meeting in August. While some Board members are content with serving a subsequent term, a whole lot depends upon whether or not other LV Ranch members are interested and willing to step-up and express their desire to serve for a term on the LV Ranch Board.

For various reasons, sometimes a Ranch Board member will need to resign their Board member position before the end of their three-year term. In those situations, our By-Laws allow the Board to appoint a Board member to serve out the balance of the vacated term. So it's important that you let us know of your interest in serving on the LV Ranch Board at any time and hopefully well in advance of the Annual Meetings in August.

FROM THE ROADS GUY

Hello from the Roads Guy!

There has been plenty of activity concerning the roads this last quarter. Lots of snow plowing both by the Retreat folks on Ellison and out to the main road as well as the Roads Guy trying to keep up with the heavy snows on other Ranch roads. This year has also included more mud than most Springs. The roads all the way to Divide have taken quite a beating this year including the paved roads. The county crews have tried to keep up with patches on the paved portions and the dirt roads have been graded once or twice. The county roads are not in very good condition now in mid-May. Please keep your speed down so you don't leave any extra parts in the chuck-holes. The roads out here on the Ranch are due some maintenance as soon as the weather allows. We had about 10 inches of very wet snow just a few days ago so it is not quite time for major road work. I will try to address individual bad spots where they pop up. We have contracted for a large pile of gravel sourced along our local roads for spot maintenance on our roads. Hopefully that gravel will be provided this spring.

We, as a Board have chosen not to do major roadway improvement projects as part of the annual budget, but to do our best to maintain the roads in their present condition with grading and fixes as needed to keep the roads up. We take our responsibility to keep the dues as low as possible very seriously so those among our Lutheran family of limited means, especially Church workers, can continue to enjoy God's beauty here at the Ranch. We do have places that could use major upgrades, especially the "Y" at the south intersection of Deer Trail and Ellison where the mud is pretty bad every Spring. Deer Trail at the north intersection with Ellison is also pretty bad during mud season. There will be smaller projects within our normal road budget such as the gravel acquired for maintenance this year and removing large rocks from Ellison two years ago. If anyone would like to contribute to the larger potential projects please contact the Board to let us know.

BEAR LAKE RESTORATION PROJECT

In February of last year, French Drains were installed to collect and route surface water into Bear Lake. As a result of that repair, along with more normal winter and spring snowfall and rainfall, Bear Lake is now approximately 1/3rd to ½ full. Yeah!

Additional repairs to Bear Lake's water inlet channel (going about 450 feet up the valley above) will be performed later this spring or during the summer. Over the many years since the lake's creation, and made worse by the 2002 Hayman Fire, the inlet water channel has become clogged up with sediment, debris and vegetation. The Ranch Board has spent approximately \$16,000.00 thus far to obtain a necessary engineering study, a permit study and to have a new French Drain system installed last year. The Ranch Board has recently approved an additional \$11,750.00 expenditure for re-trenching a new primary water inlet channel with a piping system that prevents erosion sediment from entering into the new water channel. Our annual membership dues reserve funds will only stretch so far, so if any of you should desire to financially contribute to this on-going Bear Lake restoration project, please feel free to do so by routing a contribution (in any amount) to our Ranch Post Office Box (indicating that it's a Bear Lake Project contribution). I look forward to our continued progress on Bear Lake!

COLUMBARIUM

The columbaria area has been quiet as usual.

Here is what is currently available:

The first columbaria is now completely full.

The second columbarium has only two (2) niches left.

The third columbarium has 11 niches available.

Niches are 11 1/4"(w) x 11 1/4"(h) x 10 1/2"(d). Standard size cremation containers are 6"(w) x 8"(h) x 4"(d). If you are having custom containers made, please take the dimensions of the space into consideration. The cost of a niche (which holds two sets of cremains) is \$1000. A crypt (for one set of cremains) can be reserved for \$500.

TREASURER'S REPORT

As everyone can appreciate, things just cost more these past few years and operating our Ranch is no exception. Thanks to your support, email delivery of the annual assessment invoices was a great success while saving expense on postage, letterhead, etc. Remember that dues can be paid electronically via most bank's online bill pay function. And again, we will also offer the ability to pay by credit or debit card. Please be sure to forward any contact information changes to Shirley Bauer, in membership, to be sure that you receive future notices in a timely manner.

Last year we saw a flurry of large capital or special projects expenditures, at the ranch house, the equipment yard, the ongoing revival of Bear Lake, and the enhancements of our web site. This year, in addition to some smaller upgrades at the Ranch House, the Board has approved funds (see below) to further improve Bear Lake, if this last cost estimate holds, it would bring our Bear lake revitalization project investment up to \$28,645.

Highlights: FY24 year-to-date:

Member Revenue is + \$7,700 due to the addition of 5 new members vs the 2 budgeted. Property taxes are \$1,900 less than budgeted due to a last-minute change. Except for utilities expenses at the Ranch House, we are on track as budgeted. We have reserves of \$128,500

Capital and Special project costs:

Bear Lake \$11,750 Approved by not yet spent
Ranch House Appliances \$1,746
Ranch House exterior trim \$1,580
RH furniture repair \$2,360
