LAKES, TREES AND WILDLIFE UPDATE

Starting with the Lakes. Deer Lake has (for many years) remained in good shape at water and fish supply levels. Despite some uncertainty about the likely membership attendance this past summer, Deer Lake remained stock with fish, as in past years.

The Annual Fishing Contest which was held just before the Annual Meeting on August 1st was a big success. Despite murky water from a previous day's rain, about 33 trout were caught between 9am and 11am. The fish that didn't swallow the hook too deeply were all released back. Prizes were awarded for the most number of fish caught, the biggest/heaviest fish caught (almost two pounds – a whopper), and also for the second most fish caught and the second heaviest fish. While adults are always welcome to attend and compete, this year only the kids of several memberships entered the competition. Both Ted Gates and Jim Simpson served as the Fishing Contest Judges (standing on opposites sides of the lake for fish counting and weighing purposes). It was a wonderful experience for all who attended.

The water level in Bear Lake remains non-existent, except for a small mud puddle. Two separate studies of the lake's condition were performed by separate engineering companies. One heavily focused on the water permit aspect (we don't need to pull any new permits to effect needed repairs), and the other was focused on ways to obtain better water retention.

The Ranch Board ultimately decided to attempt better development of the water source and channeling (ditching/piping) of the water from its source to Bear Lake. During the Beautify LVR Day held on Saturday of the Labor Day Weekend, many volunteers helped to cut/clear most of the Aspen trees from the lake inlet. This will allow us good access to the area in the coming spring.

During the late 1990s, Bear Lake went through a several year period of low water. Then it seemed to suddenly fill back up again and remained full for several years. It's possible that might just happen again, but the Ranch Board hopes to continue to take reasonable efforts to help it along.

Bear Alert, Maybe? Several years ago, LV Ranch suffered several occurrences of bears attempting to break into unattended RVs. It was believed that the bears had been attracted by food substances (including dried dog food) that had been left behind for future intended use. It was later discovered that the Colorado Department of Wildlife had been releasing 'trash bears' (bears which had developed a preference for trash can food) into the National Forest not too far away. After that nearby bear release practice was stopped (and the problem bears were identified and trapped), our bear problem seemed to just go away. We now have reliable information that suggests that several more 'trash bears' may have been released in our vicinity recently. For that reason, we should all be vigilant about removing all food substances from our RVs when headed back home.

Last but not least, a big thank you to Jim Simpson for providing the update above. As the rookie board member with barely a ¹/₄ of a year term served, the task of proving a status update was more than a bit daunting! Jim stepped in and bridged the gap beautifully, thanks again Jim!



EQUIPMENT

After great back and forth on the right path to follow in repairing the (new to us) Tractor we have replaced one defective battery. The battery, although not very old, had a defective cell. The battery system is wired in a series circuit so that even if one cell is defective the hole energy storage system collapses. We also discovered that the starter was failing and we had it rebuilt down in Denver and so will be in top running order for the foreseeable future. The tractors block heater should still be plugged in during cold weather for easy and reliable starting. The tractors fuel shut off (stop cable) was replaced by Rod Young and was in need of repair.

As with the grader, the equipment should be pre-inspected by checking all of the fluids before going to work. The grader and the tractor should be also post-inspected after every day of use. This will include checking all fluid levels and topping off the fuel every day the equipment is used! The winter fuel for the equipment has been delivered. I am now looking at supplying the equipment shed with much needed fluids and supplies for the maintenance of all the equipment. Please forward any suggestions for supplies to me in the future. Speaking of supplies, I am looking to buy at least one set of shelving for the supplies in the Shed. As always it is a privilege to be in our Lord's service,

COLUMBARIUM

All remains the same in the columbaria area and we have the two columbaria along with a beautiful Bench. We were hoping to have the third and final columbarium installed this summer, but delays happen. Installation will depend on weather if done before next Spring. We have also noted that our little pine trees are growing bigger!

The first columbarium has half a niche remaining. The second columbarium has seven niches available. The third columbarium has 12 niches available. The cost of a niche (which holds two sets of cremains) is \$1000. Half a niche (for one set of cremains) can be reserved for \$500. TREASURER'S REPORT

Several big purchases were made last year to help maintain Ranch Roads.

- A Tractor was purchase to help maintain the roads and take some of the wear and tear of off the grader. The grader is so old we are having problems finding parts if it breaks down.
- We purchased a 3 point land plan to pull behind the tractor to help maintain the roads.
- A walk behind bush hog was purchased to help keep the little aspen trees along the road cut down. This is to insure better visibility along the roads.
- New blades were needed for the grader.

We purchased two mobile storage units – one for Ranch use and one for the Volunteer Fire Departments use. We are storing some of our new equipment in ours. The Fire Department is storing an ATV they have that is to be used for rescues.

A television and sound equipment were purchased so Church services could be live-streamed if need be.

Two water companies were hired to study what could be done to help get water in Bear Lake.

An extra \$7,000 was given to Retreat to help them get thru these troubling times.

We had a plumber fix the plumbing in the Ranch House.

We contracted to have the Ranch House cleaned year round.

Taxes and insurance were up from last year.
