FISH, LAKES AND TREES

Catch More Trout

Trout can be very picky eaters so it is wise to have a variety of baits and lures in your tackle box or vest. If you like walking around the lakes, look into getting a fishing vest so you don't have to pick up your tackle box every time you move to a new spot.

Trout mostly eat bugs. The life of a bug is larvae, nymph and adult. Eighty percent of the feeding is under the surface eating larvae and nymphs. When you see them hitting the surface they are eating the adult flies. A lot of flies are actually dead is why they ended up there.

Some but not all of the baits that can be effective are worms, mealworms, salmon eggs, artificial salmon eggs, cheese, mini marshmallows and corn. Since they can be very picky eaters be sure to have a good variety and be ready to change your bait often. I saw a video using the artificial salmon eggs that float. It said to use #4 test line and put the hook 6 inches to 2 feet beyond the weight. This will enable the bait to float up from the bottom. The article suggested that white, orange and red are the best colors. Put two eggs (one white and one of the other colors) on the shank of a small hook. I can't wait to try it!!

Fire Free Summer

Let's keep our ranch free from fire. You can find our fire ban restrictions by searching on our website (lvranch.org) Remember to cut off branches up to 10 feet off of the ground and move branches, twigs and pine needles away from structures

ROADS REPORT

Road Conditions. The Ranch's side roads have remained in fairly good shape since they were all graded last October. No doubt this was due to moderate snowfall on the Ranch this past winter and light rainfall in the early spring. Additional dragging with the road drag should serve to maintain the roads in good shape for this summer season.

Summit Road is partially one-way. In order to repair Summit Road last October, much road dirt had to be moved back up the hill (on the steep slope) from the bottom portion. It is believed that much of the dirt displacement was caused by vehicles going uphill on the steep part. I realize that it is fun to blast up that steep hill, but in order to help preserve the road condition, we are asking members to only drive downhill on the steeply sloped portion. A one-way sign has been placed at the bottom of the hill on Summit Road (please turn around at a nearby driveway). You are asked to access the upper portions of Summit Road from the south entrance off of Ellison (the entrance closest to the Ranch House).

Side gate combination lock. The Ranch's side gate (leading into the Forest Service toward Cedar Mountain Road) has a sturdy gate (just like our front gate). That gate is kept locked with a 4-digit combination padlock (the number combination is the same as the number code to the Ranch House). At present, there are two separate combination locks and a keyed lock on the locking chain. I intend to soon paint the Ranch's combination lock with a bright florescent paint so that it's easy to distinguish. While the side gate itself is sturdy, the fencing on both sides of the gate is not. As a result, some folks have seen fit to clip the side fencing, presumably to bypass the gate while riding OHVs both out of and back into the Ranch property. We are making efforts to reinforce the side gate fencing and here ask that Ranch members respect this effort to maintain our Ranch's security. Please access the Forest Service trails through the gate itself.

Non-OHV roadway beyond Wildhorn Ranch stone gate. Effective May 26th, a new Teller County Ordinance (Ordinance 19) goes into effect. This new law makes it <u>illegal</u> to drive an OHV (off-highway vehicle) from the Wildhorn Ranch's stone entry gate going south (towards Divide) for the approximately one mile (up to the top of the hill trailheads). Thus, you can get a traffic ticket for driving any vehicle without a valid license plate upon that section of roadway. The Ranch's efforts to have the described section of roadway approved for OHV traffic were unsuccessful. This is only intended to alert you to this traffic ticket possibility. The only ticket safe alternative is to access Trail Creek Road and other Forest Service trails via Cedar Mountain Road by use of the Ranch's side gate.

Forest Service Road Application Process. A six-tenths mile portion of the Ranch's entrance roadway (LVR Trail just before the Ranch's front gate) crosses over Pike's Peak National Forest Service land. In the 1960s and early 1970s the Ranch pursued and presumably obtained the necessary Forest Service approvals to use and maintain this portion of roadway, but those approvals did not make it into the Forest Service's present computer database. The related paper files have been lost or misplaced by the Forest Service, and in February, the Ranch submitted a new road use application with the Forest Service.

The Ranch has now received temporary approval to resume road grading activities. We expect final approval of the application by year's end. Upon approval, the Ranch will likely have to start making about 2K annual payments to the Forest Service for road use. We will all need to slow down going up the hill from Wildhorn Lake as there are some wash-board sections of roadway that we are unable to fix at this time.

ESTATE PLANNING – RANCH LOT IMPROVEMENTS

Teller County recently brought a matter to the Ranch's attention. It turns out that several of the permanent houses/cabins within the Ranch are still listed under the names of deceased Ranch members with the Teller County tax assessor's office. It's important to understand that the Ranch owns all of the land. Whereas, Ranch members own the structures (houses/cabins) built on the land. These are called land 'improvements.'

Ranch members might assume that ownership of their house/cabin (improvements) will automatically pass to their surviving family members upon their death. That's not the situation here. Teller County requires that written improvement transfer documentation (signed by the owner and dated) be filed with their office before ownership of the improvement (house/cabin) is transferred to a new owner. The Ranch's re-assignment of the membership lot to another is insufficient because the Ranch transfers only who has a right to use the membership lot (land). The Ranch lot transfer does not resolve ownership of the actual home or cabin improvement.

This Teller County documentation requirement is easy to comply with while the record improvement owner is still living. All the tax assessor's office needs is the filing of a simple 'bill of sale' from the improvement owner to the intended recipient (family member).

When an improvement owner dies without leaving some sort of improvement transfer documentation, the responsibility to transfer the improvements will likely shift to the deceased person's executor (estate representative) or perhaps be a matter left up to a probate court judge to decide.

To avoid any confusion about who will own your house or cabin after you do, it would be wise to undertake the appropriate estate planning regarding your Ranch lot improvements (house/cabin).

UNCLE DAN'S NATURE CORNER - TICKS

Debbie and I recently took an early spring hike to what we call "The Amphitheater" (we name all our regular hikes). It's down Little Turkey Creek, just beyond the jeep trail turnoff to the stone cabin — a beautiful narrow spot shaded by large trees and squeezed between a rock face and the creek, an easy walk less than a mile off the road.

We sat down for a snack before hiking back to Ellison Road, but spotted a bunch of ticks crawling on our clothes. It was freaky – I removed 5 ticks and Debbie 4. On the way back we were careful not to brush against underbrush, but back at the car I found another 4 ticks and Debbie 2. We found more ticks back at the cabin, and I even found one that night when we returned home to Canon City.

Ticks will bite, embed their mouth parts, and SUCK YOUR BLOOD

So here's the scoop on LVR ticks, mainly from CSU extension. It's the Rocky Mountain Wood Tick, *Dermacentor andersoni*, especially common to high elevation forests of Colorado. They have 8 legs, more closely related to spiders than to 6-legged insects. They mainly parasitize mammals, especially rodents and deer. They can live for 3 years without feeding. They are most common in the spring, March thru June.



Here's the good news. These ticks almost never cause disease. There are no cases of Lyme Disease from Colorado. There are very few Rocky Mountain Spotted Fever cases – about 3 per year from Colorado. Other fevers are possible, including Tularemia, especially for those handling rabbits.

Ticks will crawl for hours before biting. They like dark protected spots. If not removed they will stay attached and feed for days. If the head is embedded, the tick can be carefully grabbed close to the skin with blunt tweezers or fingers (wash afterwards!) and pulled out. Occasionally the head will detach and remain embedded and can get infected. Other removal methods, such as a hot match or petroleum products, are ineffective. Like any other wound, disinfection afterwards is important.

Better is avoiding ticks in the first place, staying away from vegetation if possible. Brushing against things will transfer the clingy ticks, but they sense CO2 from breathing and can also drop on you from trees. Light clothing helps in spotting them. Insect repellent containing DEET is useful on clothing. Tick checks after exposure are essential. I sometimes store especially dirty clothing in an outdoor bin until washing. There are other types of ticks, notably the brown dog tick for pets, treated with collars, soaps, systemic insecticides - they won't survive outside thru an LVR winter.

Have a blessed spring and summer at LVR.

WHAT IS THE RANCH HOUSE? HOW DO WE SEE IT?

...For that matter, how do we see all of LVR? Is it just a way to get away, recreate, worship what we call "creation"?

I would like to introduce a "new" Way to see not just LVR, but ourselves... that word creation reminds us of it; It's what we confess when we say, "I believe..." not in creation, but The Creator... not in "getting away", but in "the communion of saint"; not in independent "do it yourselfers", but very much dependent people, people who are dependent upon two Parachletes (Helpers), One who unites us with Himself through the Word of the Other in the waters of Baptism, and through whose Word (the Word passed on from the Father to the Son, and from the Son to the Spirit, and from the Spirit to the Bride of Christ, and from the Bride of Christ to the world!

Yes! Every First Day of the week is Resurrection Day together with the Day of Pentecost: IE; High Feasts celebrating God's serving us through the two Parachletes He has sent, not because of us, but because of His Holy Name [I invite you to read Ezekiel 36 beginning with verse 21] which He lovingly and graciously desires all people to KNOW, because all people are totally dependent upon His Name to be blessed with faith by which we may be saved!

This briefly defines what and who we are as LVRers, what LVR is, and what the community building we call the Ranch House is all about! That also explains why the central activity each First Day of the week at LVR during the summer is "an open (Ranch) house" so that the two Parachletes have a place to keep their Promise to come to you, to serve you, the Bride of Christ, in accord with our Father's Holy Name!

Numbers 6:23 reminds us along with Aaron; "Thus you shall bless the sons of Israel. You shall say to them: "The Lord bless you and keep you; the Lord make His face shine on you and be gracious to you, the Lord lift up His countenance upon you and give you peace!" So they shall invoke My Name on the sons of Israel and I then will bless them!" Wow! What a Promise! Nothing in all creation can match It!
